We are happy to consider your request and provided your banner is of interest to the Community and appropriate for displaying on the perimeter of our church building we are willing to help. Here are advertising regulations that we are working from:

Description	<p><b>3D. An advertisement—</b></p> <p>(a)announcing any local event of a religious, educational, cultural, political, social or recreational character, or</p> <p>(b)relating to any temporary matter in connection with an event or local activity of such a character,</p> <p>not being an event or activity promoted or carried on for commercial purposes.</p>
Conditions and Limitations	<p><b>3D. —</b></p> <p>(1) No advertisement may exceed 0.6 square metre in area.</p> <p>(2) No advertisement may be displayed earlier than 28 days before the first day on which the event or activity is due to take place.</p> <p>(3) The advertisement shall be removed within 14 days after the end of the event or activity.</p> <p>(4) Illumination is not permitted.</p> <p>(5) No character or symbol on the advertisement may be more than 0.75 metre in height, or 0.3 metre in an area of special control.</p> <p>(6) No part of the advertisement may be more than 4.6 metres above ground level, or 3.6 metres in an area of special control.</p>
